## Voluntary by Guardian Initiative (VBG)

Voluntary by Guardian Initiative (VBG) was an initiative to place 120 consumers in state facilities with significant challenges into new community residential options that did not exist prior to 2011. Most of these individuals came in to the state facility on a voluntary basis with the majority admitted by a guardian, but some did come in with a forensic commitment. DMH created three levels of services and support beginning with the most structured:

1. The Psychiatric Individualized Supported Living (PISL) is a 2-4 person home/flat
2. Intensive Residential Treatment Setting (IRTS) is a congregate living environment between 5 and 16 beds.
3. Clustered Apartments is a structure up to 16 units of supervised apartments.
