## DBH Updates and Policy Guidance

May 31, 2019

### 1. Fiscal Year End Cut-Off Dates –

**Medicaid cutoff – 6/02/19 (Check date 6/27/19)**

**Non-Medicaid cutoff – 6/16/19 (Check date 6/28/19)**

Cutoff Dates for Services will be as follows:

**Medicaid – Applies to CSTAR/CPR/TCM/ACT/CCBHC** - The last cutoff for IGTRM Medicaid billings to use the FY19 allocation is **6/02/19** (check date 6/27/19). After the cutoff DMH Central Office will transfer all remaining dollars to Non-Medicaid for CPS. For ADA, the balance remaining in your redirect will be moved. If there is a need for more than your redirected amount please submit your request to Becky Wolken and Vicki Schollmeyer. All requests to transfer funds into IGTRM Medicaid allocations were be submitted **no later than noon on May 28th** to:

All Medicaid services billed after 6/02/19 will be paid from your FY20 Medicaid allocation.

**Non-Medicaid – Applies to CPS (non-Medicaid), CSTAR (non-Medicaid), PR+, SATOP, Compulsive Gambling, Recovery Supports and CCBHC (non-Medicaid)** - The last invoice cut-off for non-Medicaid encounters is **6/16/19** (check date 6/28/19). If you need money moved from Non-Medicaid to Medicaid Ineligibles you will need to complete the Allocation Transfer Request Form (attached). All non-Medicaid transfer requests for FY19 must be submitted **no later than noon on June 11th** to:

All Non-Medicaid services billed after 6/16/19 will be paid from your FY20 Non-Medicaid allocation.

*June 16, 2019 is a tentative billing date based on prior year information. DMH reserves the right to change this date based on the MHD RA cycle. 2. **Update on Administrative Rules** - The **CPR proposed rule amendments and rescissions** will be published in the June 3, 2019 issue of the *Missouri Register* <http://www.sos.mo.gov/adrules/moreg/moreg.asp>. Comments must be submitted as specified in the *Missouri Register*. The section for **Community Support** was not submitted for publication due to the current review of the CSTAR State Plan Amendment by CMS which may impact some aspects of this service in CPR programs.

The revised **DBH Core Rules** will be published in the May 31, 2019 issue of the *Code of State Regulations (CSRs)* and will be effective **June 30, 2019** (30 days after publication in the CSRs).

Core Rules remaining to be amended—

*Medications;*

*Emergency Safety Interventions* (replaces Behavior Management) has been posted for informal comments and will be submitted to the Governor's Office for approval in the near future; and

*Definitions* (all definitions are being moved to Core Rules, therefore this section will be updated after all DBH rules have been amended to ensure all necessary terms are included).

3. **Cost Report Training** – the [Missouri Coalition for Community Behavioral Healthcare](#) is partnering with Mercer to provide two regional PPS Cost Report Trainings. The June 6 and 7 (see below for details) trainings will be geared at ***how to complete a CCBHO cost report and highlight accounting techniques to properly calculate a PPS rate based on cost report figures***. It remains the intention of the Missouri Coalition to have all DMH contracted providers on the same payment methodology by FY 2022, with the option for some providers to start FY 2021 (July 1, 2020). The following topics will be covered:

- ✓ An overview of the cost report and PPS rate
- ✓ Enumerating visits
- ✓ Direct costs, reclassifications and adjustments
- ✓ Indirect cost allocation and unallowable costs
- ✓ Anticipated costs and visits with additional state guidance for non-participating clinics
- ✓ Complete case study and examples of properly completed cost reports

The training will include a Q&A session with Mercer which will be made into a document and made available the Coalition and its providers.

**It is recommended that each non-CCBHO provider have at least one person in attendance at one of the trainings.** Current CCBHOs are encouraged to attend as well. A follow-up webinar with Mercer will take place after the events to allow for additional questions. **Seating is limited!!** As a benefit of membership, Coalition providers will be given priority in registering for remaining slots. 4. **FSH Ribbon Cutting** - DMH hosted a very successful Ribbon Cutting ceremony at Fulton State Hospital Wednesday, May 22 with more than 200 in attendance. Governor Parson and 55<sup>th</sup> Governor Jay Nixon shared remarks, as did other elected officials and dignitaries.
5. **Trauma Informed Systems Training** - Rachel Jones, DBH Manager of Trauma Informed Treatment, provided Trauma Informed Systems training to 55 community providers at the Kansas City Regional Office on May 14. She provided guidance and consultation to the Kansas City Trauma Team that is working to move organizations toward Trauma Informed agency status. She will provide two additional staff trainings – Universal Trauma Training and Trauma

Informed Systems -- and continue to support their Trauma Team in strategic planning and organizational change. She is scheduled to provide similar training at the Rolla Regional Office on June 28.

**Medication Awareness Recovery Specialist Training** - The MCB will be starting a new 40 hour Medication Awareness Recovery Specialist Training Program on **Friday July 12th, 2019**, with live training in Jefferson City, St. Charles, Springfield, Kansas City and Cape Girardeau. This program is a comprehensive training program that provides 40 hours of training on using medications during the recovery process. At the conclusion of the program, participants are awarded 40 CEU hours and a Medication Awareness Recovery Specialist Certificate. The program details are as follows:

The program starts on Friday July 12th, 2019 with a 1 day live training in Jefferson City, St. Charles, Springfield, Kansas City and Cape Girardeau. Participants choose 1 live training to attend from the 5 options.

Participants then work through 8 self-study modules that start Monday July 22nd, 2019 and end Sunday October 13th, 2019. These modules are completed at home within assigned time periods.
