- Dual Enrollment Notice** - Effective November 1, 2019, the following programs will no longer be available for dual enrollment:
 - Adult Community Services with Adult CPR
 - Youth Community Services with Youth CPR

- CPR Maintenance Reminder** - The Maintenance level of CPR is **coded to end October 31, 2019**. Effective November 1, you will no longer be able to bill for any consumers enrolled in this level. A **revised report** showing all consumers currently enrolled in the Maintenance level has been placed in all provider's FTP folders (Reports/CPS). **Please move all Adult and Youth CPR consumers from the Maintenance level into the Rehab level.**
- Clarification on SSN Status Message** - When a consumer is entered or when there are changes to the consumer's information that requires a re-verification in CIMOR, a status message will show "Not Sent for Verification." This status is to inform one that the verification process has not yet been initiated. One does **NOT** need to request the verification process, as the verification process begins around 3:00 PM daily. If the status remains unchanged for **TWO DAYS**, please contact the help desk. *[This was a CIMOR Priority Alert sent earlier this week. SAMHSA - CSAT is accepting applications for Federal Fiscal Year (FY) 2020 Grants for the Benefit of Homeless Individuals (Short Title: GBHI). *The purpose of this program is to support the development and/or expansion of local implementation of a community infrastructure that integrates substance use disorder treatment, housing services and other critical services for individuals (including youth) and families experiencing homelessness.*

Eligibility: **Eligible applicants are domestic public and private non-profit entities.** SAMHSA seeks to further expand the impact and geographical distribution of its targeted homeless programs. Therefore, recipients funded under the following announcement numbers are not eligible to apply for this funding opportunity:

TI-17-009 (GBHI) – Grants funded in FY 2017, 2018, and 2019

SM-18-014 (Treatment for Individuals Experiencing Homelessness) – Grants funded in 2018 and 2019

In addition, the statutory authority for this program specifies that these grants must be made to community-based public and private non-profit entities. Therefore, states are not eligible to apply.

SAMHSA is accepting applications for Federal Fiscal Year (FY) 2020 Expansion of Practitioner Education (Short Title: Prac-Ed) grant. *The purpose of this program is to expand the integration of substance use disorder (SUD) education into the standard curriculum of relevant healthcare and health services education programs.* Through the mainstreaming of this education, the ultimate goal is to expand the number of practitioners to deliver high-quality, evidence-based SUD treatment. The National Survey on Drug Use and Health (NSDUH) 2018 data indicate that an unacceptably high 92% of individuals who meet criteria for needing SUD treatment do not receive it. SAMHSA is implementing this program as one of the many steps to reduce barriers to accessing and providing care.

Eligibility: Public or private non-profit professional associations representing healthcare professionals in the fields of medicine, physician assistants, nursing, social work, psychology, marriage and family therapy, health services administration OR public or private nonprofit entities which are universities, colleges or other professional schools.

Recipients who received funding under FG-19-001 are not eligible to apply for funding under this FOA.

2. **First-Episode Psychosis and Co-Occurring Substance Use Disorders** - The transition to adulthood can be especially challenging for young people who experience an emerging serious mental illness such as first-episode psychosis and who have a co-occurring substance use condition. When first-episode psychosis and substance misuse occur together, outcomes tend to be poorer in both the short and long term. For young people experiencing first-episode psychosis, reducing or stopping substance misuse yields significant improvements in psychotic symptoms, depressive symptoms, and the young person's ability to lead a meaningful life. SAMHSA's new guide, First-Episode Psychosis and Co-Occurring Substance Use Disorders, supports health care providers, systems, and communities to address first-episode psychosis and co-occurring substance use disorders. It describes relevant research, examines emerging and best practices, identifies knowledge gaps and implementation challenges, and offers resources. [Download the Guide](#)
3. **FDA Approves First Transdermal Antipsychotic Patch for Schizophrenia in Adults** - The FDA on October 15 approved the first transdermal patch of an established antipsychotic for treating schizophrenia in adults. In addition to offering a new delivery option, transdermal patches can also provide caretakers and healthcare providers with a nonintrusive, visual confirmation that a treatment is being utilized. The once-daily transdermal drug delivery system (TDDS) created by Noven Pharmaceuticals provides sustained concentrations during a 24-hour wear time of the atypical antipsychotic drug asenapine, an established treatment for schizophrenia. Dr. Naruhito Higo, Chairman and Chief Executive Officer of Noven said his company "looks forward to bringing it to market in the U.S. as soon as possible so people living with schizophrenia have a transdermal delivery option for asenapine treatment." In an international, Phase 3, double-blind, placebo-controlled study, SECUADO achieved the primary endpoint of statistically significant improvement from baseline in the change of the total Positive and Negative Syndrome Scale (PANSS) compared to placebo at week six. Efficacy and safety were assessed during the six-week treatment period in 616 adults living with schizophrenia. Additionally, SECUADO demonstrated statistically significant improvement in Clinical Global Impression-Severity (CGI-S) scores, the key secondary endpoint of the Phase 3 study. (Source:
