# DBH Updates, Notices, and Policy Guidance March 6, 2020

- 1. Budget Update On Tuesday, March 3, the House Budget Committee heard recommendations from the chair of the sub-committee on Health, Mental Health and Social Services. There was only one recommended change. The House Budget Committee will hold a future meeting for their recommended changes. On Wednesday, March 4, the House Budget Committee heard recommendations for the supplemental bill. The bill was passed by the House and there is a hearing scheduled in the Senate for Tuesday, March 10 at 8:30 a.m.
- 2. COVID-19 Update We know many of you are keeping a watchful eye on the news as it relates to coronavirus (COVID-19) developments in the US and worldwide. We trust, as experienced community providers, that you understand the importance of staying calm, but also being prepared. We wanted to let you know a few of the things the DBH is doing to be prepared as it relates to supporting our community providers in service continuity. Our primary goal is keeping clients stable, while minimizing both agency employees' and clients' exposure to contagious illnesses.
  - DBH administrative staff met this morning to begin discussions about policy and program requirements that may need to be relaxed or suspended. While this situation is unique, our prior experiences with the Joplin tornado and even the Ferguson unrest are helping us consider some of the potential issues.
  - We have a call with MO HealthNet scheduled next week to discuss joint program rules, their preparedness plans, and next steps should the situation escalate.
  - We are reviewing internally our plans for provider monitoring visits, large group meetings, etc. to discuss rescheduling these or using other avenues for accomplishing the tasks, should that become necessary.
  - We are working closely with other state departments to share information and ensure consistent messaging.

### What we ask of you at this time:

- Please review your own policies and procedures related to infection control and offer refreshers to staff as appropriate.
- If you do not have policies and procedures related to infectious illnesses in larger group settings (i.e., PSR, residential care, housing, detox, dosing at OTPs, RCCs), now is the time to consider what may be appropriate.
- Evaluate your waiting areas and consider ways to minimize risk of transmission of contagious illnesses.
- Make sure you are getting information from reputable sources (i.e., the CDC,WHO).

### **COVID-19 Addendum**

In addition to our review of community operations, we are also reviewing continuity of operations for our state inpatient hospitals and working closely with the Department of Corrections and the Missouri Hospital Association. (New Today) Based on a call we listened to this morning, here are some additional areas of consideration in terms of preparedness:

- Document any and all additional expenditures in case disaster funds become available.
- Fiscal planning is very important and should include CFOs so that fiscal expenditures can be prioritized and projected to ensure sufficient cash/resources are on hand to address the need for:
  - Anticipating the need for additional staffing
  - o Paying more for in-demand supplies
  - Establishing back-up vendors
- Not all legal regulations may be waived or relaxed because we are technically "on notice" versus being in a
  "declaration" of emergency or disaster...you should still do everything possible to anticipate how best to

ensure HIPAA and 42 CFR Part 2 compliance, protect client privacy, and reduce unnecessary or inappropriate disclosures of information (a scenario we identified might be getting consent for electronic transmissions that may not be as secure as telehealth).

- Its recommended that you establish <u>in advance</u> what positions in the agency could potentially telecommute/work from home and which ones cannot.
- If you use contracted professionals (e.g., community docs), ensure there is some agreement for back-up in case that professional is ill or otherwise unable to treat clients.
- Establish an authority matrix for your agency...who can make decisions, who can access funds to pay bills, etc.
- 3. DBH Deputy Director of Administration Named We are welcoming Gina Jacobs to the Division of Behavioral Health as the new Deputy Director of Administration. Ms. Jacobs has been employed by the Department of Social Services for 23 years, serving in many capacities at DSS, most recently as the Deputy Director, Operations Management. She comes to us with broad experience, and we are excited to have her join the Division. Ms. Jacobs will oversee our outstanding Fiscal and Research Departments and will have the advantage of working with a knowledgeable, caring and hard-working staff. We hope that many of you will assist her in understanding our complex facility and community operations. It will be important that she see firsthand the innovative work that you do on a daily basis to improve the lives of those we serve. Ms. Jacobs will assume her new position on April 1.
- 4. SOR GPRA Update On March 5, 2020, the Department of Mental Health (DMH) deployed the updated State Opioid Response (SOR) Government Performance and Results Act (GPRA) into CIMOR. The following business rules will be relaxed until September 30, 2020, (which is the duration of the Opioid SOR Grant YEAR 2):
  - 1. Providers can only add a GPRA within the last thirty days.
  - 2. Providers can only bill a service with a current (initial or follow-up) GPRA on file for the consumer.

Effective October 1, 2020, the relaxed rules will revert back to the original rules. Providers will only be able to add a GPRA interview date within the last 30 days from the current date for a consumer. For example, if the current date is 10/01/2020, CIMOR will only allow a GPRA interview date from 09/01/2020 to 10/01/2020. The provider will not be able to add an encounter for ADA Opioid SOR Grant program without a current GPRA. - 5. Trauma-Informed Schools ECHO Missouri Telehealth Network (MTN) launched Trauma Informed Schools ECHO (Extension for Community Healthcare Outcomes) with the goal of assisting school districts interested in making trauma informed system changes and helping students and families get access to mental health services. DMH and DESE have partnered to promote this tele-mentoring opportunity for school districts and local community mental health providers. Interactive video conferences are held twice a month at no cost to participants and covers topics including adverse childhood experiences, assessment methods, brain-based research and classroom strategies. <a href="https://showmeecho.org/clinics/trauma-informed-schools/">https://showmeecho.org/clinics/trauma-informed-schools/</a>
- 6. CCBHO QIP reporting- If your agency has not submitted FY19 shadow claims for the QIP measures, the final submission due date is March 31, 2020. The estimated QIP payout date for this submission is May 15 June 1, 2020.

- 7. Transforming Lived Experience Award We congratulate, Missouri's own, Rick Strait who is receiving the American Association of Suicidology's "Transforming Lived Experience Award" at this year's annual conference! Rick is a suicide attempt survivor and impacted family member. His primary job is with Community Counseling Center where he served as the Integrated Treatment for Co-occurring Disorders program manager and Suicide Prevention Coordinator. Rick plays an integral role in spreading suicide prevention throughout Missouri, as well as the nation.
- 8. Opioid Use Disorder ECHO Missouri Telehealth Network (MTN) is offering another ECHO (Extension for Community Healthcare Outcomes) for Opioid Use Disorder. ECHO empowers and supports primary care providers to more effectively and confidently treat patients suffering from opioid use issues. The Opioid Use Disorder ECHO integrates medical, pharmacological and psychological considerations into patient care. Substance use specialist knowledge provided in a virtual learning network with experts from Truman Medical Centers, Assisted Recovery Centers of America, Midwest Addiction Technology Transfer Center, Collaborative for Excellence in Behavioral Health Research and Missouri Department of Mental Health.

- Decrease opioid-related morbidity and mortality rates by using a medication-first strategy
- Teach evidence-based principles for harm reduction, recovery and support strategies to supplement effective treatment
- Improve compassionate, patient-centered care for individuals with opioid use disorder

- 9. **Top Substances at Admission** While the opioid crisis has affected thousands of Missouri's families, a resurgence in methamphetamine is of significant and increasing concern in several areas of the state. In a recent FY19 report of the top substances reported as reasons for admission to DMH-contracted treatment providers, it was found that there were regional differences.

By region, here are the top three (3) substances cited at admission:

- Eastern: Opiates, alcohol, methamphetamine
- Southeast: Opiates, methamphetamine, alcohol
- Southwest: Methamphetamine, alcohol, opiates
- Western: Methamphetamine, alcohol, marijuana

### Other trends reflected in the report:

- Methamphetamine has been one of the top six primary substances since 2011.
- Methamphetamine admissions have nearly doubled since 2011.
- Alcohol and marijuana admissions are trending downward; methamphetamine and opioid admissions are trending upward.
