I have 2 adult children, and my youngest daughter has a developmental disability.

I began my involvement with the local regional office as a member of the regional advisory council, and then later worked as a parent policy partner before actually becoming a state employee.

I've been involved in the D. D system and work in this field since the early nineties.

And Matthew want to give a brief introduction. Good afternoon. Everybody my name's Matt Wagner. Like, we've identified, I am the information specialist, statewide lead. I've been with the division for near on 21 years.

Um, I have 2 children, both of which carry the diagnosis of autism. Um.

14

Prior to becoming the information specialist, statewide lead, I was the intake, an assessment supervisor for Joplin and then oversalt part of the process in Springfield for about 12 years.

Total, um, I've been in the field of developmental disability services since 9,998 so we're coming up on 2324 years.

It's great to be with you. All thanks, Matt. So, as parents and caregivers, Matt, and I both know 1st hand how important it is to have the information that we need.

And over time, other families have also shared that 1 of the most important things that they need is access to relevant to date information and resources.

Uh, we'll talk a little bit about the overview of eligibility for services, getting into the services with the division and then we'll talk a little bit about, um, some of the basic services that you can expect to get. If you are determined eligible.

I hit the wrong button, so it was already part of my mental health division. Developmental Disabilities provides a multitude of services for missourians within developed with developmental disabilities.

We have our.

Requirements for eligibility, laid out, not only in statute, which is revised statute of the state of Missouri, which is basically law.

29

But then in more detail in code of state regulation, um.

We have basically the system divided into 2 general settings and again today is more of a.

30,000 feet overview. There is no way that we can get into all the details of services.

In 30 minutes, but it gives you kind of a a brief understanding. So we have community based services and we have visitation center or, uh.

Other type of and we don't really have that many facilitations based services, but but that's how things are divided.

Um, so, community based services are administered through 5, regional offices and 6, satellite offices. And here's a quick Matt, just to kind of break down how they are provided St. Louis is your light blue and Hannibal.

Kansas City is in yellow,

which encompasses the satellite office of Albany,

central Missouri in purple,

which also encompasses Rolla and Clarksville,

Springfield,

which is like green,

which has Joplin as your satellite office and then,

which is pink and they have poplar bluff.

So, that's how the state is divided up into regional offices, satellites and actual regional offices.

So eligible eligibility for services is based upon the federal definition of developmental disability.

So if you take federal money, you play by federal rules, so, Missouri has basically a 5 point eligibility criteria to be determined eligible for services. The 1st thing is a diagnosis and here's what's interesting.

Missouri doesn't operate off of a specific list of diagnosis.

Even though the DSM 5, which is the diagnostic and Statistical Manual version 5.

Changed the criteria for an intellectual disability.

From 18 to what they call early adulthood.

In the state of Missouri, we still mandate that intellectual disability be diagnosed.

Add or by the age of 18, and that's because our statute.

52

Is very specific stating it has to be to the age of 18 everything else. We look for the presence of the disabling condition prior to the age of 22.

So that's kind of an interesting point to talk about. Does that mean that we have to have the diagnosis prior to the age of 22.

Not necessarily there are times, especially when we're dealing with autism that we might need historical data that can demonstrate that the symptoms were present.

Perhaps there was a misdiagnosis.

Early on there are some other diagnoses that resemble autism or some characteristics they share characteristics like skits, affective disorder um, other, um, what we would consider mental health diagnoses.

We would need kind of a thorough evaluation and a description of why the.

Diagnosis was given that was wrong or misdiagnosed, but it doesn't mean necessarily it has to be diagnosed prior to the age of.

22 the symptoms have to be present and that has to be documented. It is not likely to improve, which means that sometimes people might sustain a spinal cord injury or a traumatic head injury. And, um.

60

They are slated to make a full recovery that's not considered a developmental disability. It may be a disabling condition, but it isn't a developmental disability because it doesn't meet the criteria that it isn't likely to improve.

We also are going to look at substantial functional limitations in 2 or more areas. Um.

62

The feds indicate that there are 7 areas.

63

Of substantial functional limitation, self care, communication, learning, mobility, self direction.

64

Socioeconomic, and then capacity for independent living 7, Missouri, combined the final 2 into 1 area.

65

Um, and then there is a need for specific or generalized facilitative training and that's an interesting term. Not a lot of people use the term facilitation a lot.

Uh, you've heard the term rehabilitation, which is the re, acquisition of a skill.

67

habilitated is the initial acquisition of the skill typically meaning that the individual did not acquire that developmental level or skill at the appropriate time frame due to the disabling condition.

68

So the need for habilitated, which is ongoing training to acquire the skill is needed beyond the developmental cut off.

69

So, there are a couple of services should you be determined eligible and so your intake department they, they are going to be looking at those 5 areas when they say yes. Or no to an eligibility determination.

70

They're going to be asking about a diagnosis. They're going to be looking at the age of onset. They're going to be looking at substantial, functional limitations. They're going to look to see if it's gotten better or if it's likely to get better.

And they're going to determine if there's a need for generalized or specific habilitated training.

72

Right. And so that's why they all collect documentation from doctors and therapists and schools, and anybody out there that we can find that's got documentation to support the presence of that diagnosis.

If you are determined eligible. Because Missouri is now considered a Medicaid system, you're going to be eligible for the possibility of 2 different services.

74

Initially the 1st, 1 is support coordination and that is if an individual is eligible for Medicaid and actively receiving a Medicaid service.

Or support, then they can receive support coordination from either a local regional office, or from a community partner being an of community, mental health, or other approved agencies.

76

If the individual does not have Medicaid, but resides in a county that has what we call an intent to serve.

77

They will receive some sort of a support through their community partner.

78

These community partners are under no contractual obligation to the division to provide a service to an individual who does not have Medicaid because they are providing that service.

Basically, Pro, Bono and out of the kindness of their heart.

If you do not have Medicaid, you're will be referred to the information specialist system. And that's the program that I oversee for lack of a better term. The easy way to describe it is group case management or resource and referral.

So we have about 22 counties currently that participate in the information specialist system. So that is any.

82

A county that is served by a regional office support coordinator, or for any county that does not have an intent to serve non Medicaid individuals. They're going to be.

They're going to participate through our system, which is basic resource and referral and I'm going to tell you that our primary goal in life is to get you out of our system and get you to support coordination.

Most of the time folks are eligible for Medicaid.

Uh, maybe they haven't applied for the right program.

86

We're going to figure out some way, hopefully to get you eligible for Medicaid.

And get you into support coordination or case management.

Throughout the easiest way that people transition out of our program is their Medicaid is activated.

89

They have an autism diagnosis, and they are requesting funding through, um, through a parent advisory council, or they move to a county that has an intent to serve.

This is our map, so the autism projects are basically broken down here.

For individuals that want to access autism, funded services, the general revenue, you can see that. There are 5 regions.

So, we did not know that the regional office existed, and we certainly did not know that the division of DD existed. So.
