#### What is a Medicaid HCBS waiver?



- Medicaid Home and Community-Based Service
   (HCBS) Waiver programs help provide services to
   participants who would otherwise be in an institution,
   a nursing home, or a hospital, to receive long-term
   care in the community.
- Medicaid funding for the HCBS waivers in Missouri consists of state general revenue dollars and federal dollars.

## Eligibility for a Division of Developmental Disabilities (DD) Waivers



- Be eligible for MO Division of Developmental Disabilities (DD).
- Be MO HealthNet (Medicaid) eligible as determined by Missouri Family Support Division.
- Evaluation of Need for <u>Intermediate Care Facility</u> for Individuals with <u>Intellectual Disability (ICF/ID) Level of Care:</u>
  - Meet the <u>federal definition</u> of a developmental disability (three substantial functional limitations).
  - Have active habilitation needs.
  - Reasonable indication that the individual has needs that could be met with ICF/ID services unless provided Home and Community Based Services under the Waiver.
- ICF/ID LOC determined initially and are re-evaluated at least annually or as specified in the approved waiver.

# **Important Facts About the MOCDD Waiver**



This waiver serves 366 participants and does not have an annual cost cap.

The child must be determined not eligible for any MO HealthNet program.

If the child has MO HealthNet spend down or premium, the family must explain why this is a financial hardship and cannot be met.

What you need to know

The child must be living at home with family and under the age of 18 to be supported in this waiver.

The MOCDD Waiver IS NOT for children who only need MO HealthNet services such as private duty nursing. Private duty nursing IS NOT a service through the MOCDD Waiver.



# Important Facts About the PFH Waiver



This waiver has an individual cost cap of \$12,362.

There is an exceptions process to exceed the individual cost cap.

SB40 and the Division of DD will each pay half of the match for each PFH waiver slot.

What you need to know

Services only available in PFH:
Family Peer Support
Dental
Temporary Residential Services

The participants must be residing in a participating county and meet crisis or priority criteria.

#### **Waiver Renewal Process**



- Home & Community-Based Service (HCBS) 1915(c) Waiver Applications renew every 5 years.
- Partnership for Hope (PFH) and Missouri Children's with Developmental Disabilities (MOCDD) Waiver Applications were approved by Centers for Medicare & Medicaid Services (CMS) are set to renew July 1, 2023.
- The waiver renewal process starts several years in advance of the waiver renewal date.

#### **Waiver Renewal Process**



- Stakeholder input
- Reports for performance measures
- Public Comment
  - Informal & Formal
- MO HealthNet review of changes
- Submission of waiver application to CMS
- Question and Answer with CMS
- CMS Waiver Approval
