

Prohibited Practices

What is a Prohibited Practice?

Prohibited practices are restrictive procedures that are likely to cause harm, used as punishment, for staff convenience, or are in lieu of engagement, active treatment, or behavior services; or otherwise dehumanize an individual.

Types of Prohibited Practices

Physical Restraints

When physical force or technique is used to restrict the movement of another individual and staff are not competently trained or certified to do so. When restraints are used improperly or excessively and/or if the restraint is used for reasons other than to prevent imminent harm of self/others.



Chemical Restraints

Prescription or over the counter medications administered for behavioral control not part of a safety crisis and/or behavioral plan.



Restricting or limiting a person's movement in their own home in lieu of active behavioral support or restricting access to the outside.





Seclusion

Time out placement in a secured room/area and preventing the individual from leaving (e.g. safe-room).

Mechanical Restraints

Device, instrument, or object used to confine or limit freedom of movement whereby the individual can not move it (e.g., enclosed crib, barred enclosure, locking people in their home)

Why are Prohibited Practices used?

- The individual has a support need that is not being met. Additional professional help may be needed such as behavior therapy, occupational/physical therapy, and/or counseling.
- The individual may not have the appropriate skills. Supports should be aimed at addressing skill deficits (e.g., communication, self-management, social skills).
- Staff are not adequately trained on alternative strategies to support the individual and instead are using restrictive/prohibited practices.
- Restrictive/prohibited practices are used to influence and control the individual in order to manage problem behavior.

Restrictive practices limit rights, belongings, events, activities, and/or the ability to move or access our environment.

What do you do if you discover a Prohibited Practice?

 You should report it. See <u>Guideline</u> 85 for more information about the reporting process.

What is Behavior Support Review Committee?



The Behavior Support Review Committee is the Divisions way to provide support to teams across the state who provide services to individuals exhibiting complex needs through clinical consultation and follow-up coaching. The overall goal is to promote the implementation of best practice strategies leading to greater independence and an enhanced quality of life.

Who is the Behavior Support Review Committee?

It consists of the following:

- Three regional licensed behavior analysts who function as the chairpersons of the committee along with three Intensive Systems Consultants
- A member or members of the provider community licensed to practice applied behavior analysis or working towards licensure
- Other professionals as necessary to review the information and provide feedback


