On May 1, 2023, the Division of Developmental Disabilities initiated Phase II of the Health Risk Screening Tool (HRST) Process. During Phase II, all Division contracted residential service providers and targeted case management providers will begin using the Health Risk Screening (HRS) process for individuals they serve, in alignment with the individual's Individual Support Plan (ISP) process. The Health Risk Screening process begins with the HRST, which is an assessment tool used to provide early detection of potential health risks and destabilization factors.

Individuals and family members can view educational videos that describe the HRST's purpose, <u>Health Risk Screening Tool</u>, and how they can help ensure accurate scoring of the HRST, <u>Your Input is</u> Vital.

#### FHIR-ed Up for Interoperability

The Department of Mental Health (DMH) - Division of Developmental Disabilities (DD) alongside the three Missouri Health Information Networks (HINs) – Lewis & Clark Health Information Exchange, Tiger Institute, and Velatura HIE – began technical requirement gathering sessions on July 27, 2023.

 In the sessions, the team is engaging in in-depth discussions, exploring a multitude of aspects to gather essential requirements and glean valuable insights to ensure a seamless and effective implementation process that utilizes eLTSS (Electronic Long-Term Services and Supports) Fast Healthcare Interoperable Resources (FHIR®) Implementation Guide (IG).

DMH - DD led an educational session on the development of the person-centered care plan titled <u>The Digital Future: Integrating the Person-Centered Care Plan for Individuals with IDD Across the Healthcare Ecosystem</u>. The session aims to introduce Long Term Services and Supports and Home and Community-Based Services Waiver Programs. It also seeks to explain the concept of a personcentered care plan for individuals with intellectual and developmental disabilities and to showcase how the DMH data exchange project can benefit different care providers by enhancing data accessibility, care coordination, and clinical decision-making while reducing administrative burden and potential costs.

DMH - DD is collaborating with OA-ITSD to finalize the procurement and onboarding of a third-party technical vendor in August 2023 to support implementation.

• The vendor's primary role will be to facilitate data mapping from various sources to the DMH data warehouse and oversee the implementation of the data exchange project. The selected vendor will be responsible for configuring and deploying the necessary software and infrastructure required for the data exchange to function effectively. By efficiently integrating data into the DMH data warehouse, the HINs will be able to seamlessly facilitate the exchange of person-centered data across Missouri's healthcare ecosystem.
