MO DD Health Home

MISSOURI DIVISION OF

DISABILITIES

- The Division continues to work with Missouri Department of Social Services, MO HealthNet Division (Medicaid), to implement a DD Health Home.
- A DD Health Home will help coordinate care for individuals served through the Division (those receiving waiver services as well as those not receiving waiver services) who have qualifying health risks and chronic health conditions.
- The DD Health Home will be a separate program from Missouri's other Health Homes: Community Mental Health Center Healthcare Home & Primary Care Health Home.



MO DD Health Home



- Access to a team of healthcare professionals that promote wellness and a healthy lifestyle.
- An additional partner to help individuals and Support Coordinators identify health needs and goals.
- A state plan program funded through MO HealthNet that will not affect an individual's current MO HealthNet (Medicaid) benefits or services.



MISSOURI DIVISION OF

DISABILITIES

- A home. It is not a place to live and does not change where the individual lives.
- A direct medical service. It does not take the place of an individual's primary care physician, medical specialist, or home health services.
- Replacing an individual's planning team.
- A waiver service.



MO DD Health Home Eligibility



Who is eligible?

Adults and youth receiving Division of DD services who are covered by Medicaid if they have a chronic condition of intellectual and/or developmental disability, and have or be at risk of developing one of the following conditions:

- Diabetes;
- 🕾 Asthma;
- Cardiovascular disease or hypertension;
- Chronic Obstructive Pulmonary Disease (COPD);
- Overweight (Body Mass Index (BMI) > 25);
- Dementia;
- Dependent on a ventilator;
- Tobacco use;
- Diagnosis of Autism Spectrum Disorder;
- One of the Fatal Five Plus Conditions: Pulmonary Aspiration, Bowel Obstruction, Gastroesophageal Reflux Disease (GERD), Seizures, Sepsis, Dehydration;
- Using the Health Risk Screening Tool that identifies potential risk for individuals with a Healthcare Level of 3 or greater.



MO DD Health Home ' How do individuals enroll?



Auto-enrollment of individuals

- The Division will auto-enroll eligible individuals and assign individuals to a DD Health Home Provider.
 Individuals will receive a letter indicating they have been selected to participate in this program, the benefits of the service, and the individual's assigned
 - DD Health Home Provider contact information.

🤊 Opt Out

- Individuals have the choice to opt out whenever they choose, or request a different DD Health Home Provider.
- This program is completely voluntary.



MO DD Health Home Providers



- Providers will be DD Targeted Case Management Agencies and DD Home and Community Based (HCBS) Waiver Service providers.
- OD Health Home will give eligible individuals the opportunity to receive Health Home services from Division providers who have knowledge and experience with supporting individuals with intellectual and/or developmental disabilities.







What does the DD Health Home do?

- Helps individuals live healthier by:
 - Developing healthcare goals with an individual, helping individual meet their goals, and tracking goal progress.
 - Providing education on general health and wellness.
 - Assisting individuals with understanding and managing their specific health conditions, medications, and treatments.
 - Adding health care experts to the individual's team.
 - Reeping individuals connected to their current doctors and medical specialists.
