MO Division of Developmental Disabilities Surveys 2024-2025 Surveys: We Need Your Feedback!

The MO Division of Developmental Disabilities (DD) has begun a new survey cycle. The Division participates in three National Core Indicators (NCI) surveys and the Missouri Quality Outcomes (MOQO) survey. These surveys ask people with intellectual and developmental disabilities (I/DD) and their families about their lives and services.

People receiving Division of DD services are randomly selected to participate in these surveys. If you or your family is selected, you will be contacted by mail or telephone. Mail surveys will come from the University of Missouri-Kansas City Institute for Human Development (UMKC-IHD). Telephone contact will be made by staff from your local regional office. If you have the chance to participate, please do! All survey responses are anonymous and help to make services better for everyone. The 2024-2025 survey cycle ends June 30, 2025.

TTI provides educational professionals, service agency staff, parents, and other collaborators involved in the transitioning of individuals with disabilities (high school into post-school) opportunities to receive relevant and current information on programs, projects, research, and best practices occurring around the state related to transition.

The Missouri Department of Mental Health, Division of Developmental Disabilities is preparing to launch Round 2 of the HIE Onboarding Program by early summer. This initiative aims to expand the network of Home- and Community-Based Services (HCBS) providers that can securely collect, share, and access data through the Missouri Health Information Exchange (HIE), enhancing care coordination for individuals they serve. Over the next month, the Division will collaborate with Health Information Networks (HINs) to identify and engage interested HCBS providers. Additionally, in April, the Division kicked off the Electronic Long-Term Services and Supports (eLTSS) Project in partnership with Lewis and Clark Information Exchange (LACIE), Tiger Institute Health Alliance, Velatura Health Information Exchange, and SHINE KONZA. For the first time, all four of Missouri's HINs are working to come together to support statewide person-centered care coordination using innovative standards-based technology. This initiative will enable seamless data exchange between health and HCBS providers, ensuring that individuals with intellectual and developmental disabilities receive more integrated and effective care across the state.

The Real Voices, Real Choices conference, presented by the Missouri Mental Health Foundation and the Missouri Department of Mental Health, is designed to inform, educate, and empower people who have lived experience and/or receive services for mental illness, substance use disorders, and intellectual and developmental disabilities.

Missouri State Parks Beach Chair Program

Missouri State Parks strive to provide accessible outdoor recreation for all and currently has 18 beach chairs available across the state. Beach chairs can help visitors with limited mobility gain access to designated swim areas that may not be suitable for traditional wheelchairs. Beach wheelchairs are equipped with large wheels and arm rests that help with moving across terrain as well as keeping the chair afloat.

Beach chairs are free and available on a first-come, first-serve basis during normal beach hours. Visitors needing a beach chair should contact the part office to ask about availability. Beach chairs can support up to 253 pounds.

It is a statewide resource hub filled with videos, resources, infographics, and messages of hope all centered around the common experiences of transitioning from adolescence into adulthood. This hub is dedicated to addressing and facilitating the essential aspects of this transformative journey to adulthood.

Explore LIFELAUNCH where you will find stories from youth about their journeys, find a variety of resources targeted toward wellness and gaining life skills, and links to resources that address mental health wellness, substance use, and the eight dimensions of wellness. Resource topics are available to assist with planning for housing, gaining more independence, finding employment, financial education and stability, nutrition, safety, and navigating adult healthcare. Professionals who work with youth will find resources that will help them support their efforts including connecting youth to peer support, how to build healthy relationships, working with parents/caregivers, and more.
